1. Terms of Coverage:

UonDVD agrees to videotape the wedding and reception of

a **Client**: _____ Name and address of the event _____

- a. **UonDVD** agrees to produce a wedding video which shall include, so far as possible, the wedding ceremony in its entirety and highlights of the wedding reception, subject to the physical constraints of the venue, including but not limited to factors such as the location of cameras during the wedding ceremony, the amount and quality of ambient light, and special restrictions placed upon the videographers by the **Client**, the Bride and Groom, the officiant and officiant's representatives, and those responsible for the venue(s) in which the wedding and reception take place..
- b. Unless requested or agreed to by the Bride and Groom, **UonDVD** will not use artificial lighting during the wedding ceremony.
- c. UonDVD agrees to provide at least 2 manned cameras for wedding coverage, and at least 2 manned cameras for coverage of the reception. At the discretion of a **Client**, additional manned and unmanned cameras may be used, at the Client requirement.

2. Fees and Services:

Depending on the package and or optional services the **Client** would choose from UonDVD web site (www.uondvd.com), the fees and the services are determined.

- d. Music for the wedding video tape will be supplied by the Bride and Groom, who are solely responsible for obtaining permission to use this music.
- e. *No work can be initiated on the wedding video until all materials to be included, such as the wedding invitation, program, photos and special music, have been delivered to **UonDVD**.*

3. Retainer

A retainer of \$_____, one third the contractual fee, must be paid at the time of booking. This retainer secures the date for **UonDVD** services. It is the **Clients'** guarantee that **UonDVD** will not book someone else in the **Clients'** time-slot.

The retainer is non-refundable, except as noted in Paragraph 5 of this contract.

4. Balance of Payment

Balance of the contractual fee is due in two weeks prior to event.
No videotape, either in progress or completed, may be removed from the videographer's premises until balance of payment has been made in full.

5. Exact Date

The agreement between **UonDVD** and the **Client** is for the exact date specified in this contract.

- If professional sound mix is required (Readers, Vocalists, Musicians, etc.), additional microphones, sound board mixer, and sound engineer will be provided. \$250

In the event of the cancellation or postponement of the wedding and reception, the retainer is non-refundable, unless **UonDVD** has been notified of the cancellation at least sixty (60) days prior to the contractual date. If the wedding and reception are postponed and rescheduled, **UonDVD** agrees to shoot on the new date under the terms of this contract, subject to availability.

If **UonDVD** is unavailable to shoot on the rescheduled date, this contract will be null and void.

6. UonDVD as Priority Videographer

It is understood that **UonDVD** is the priority videographer. Because of their potential to disrupt video taping by **UonDVD**, we ask that video lights and wireless microphones not be used by other videographers during the wedding ceremony.

UonDVD assumes no responsibility for the quality of video or audio if lights or wireless microphones are used by other videographers.

7. Raw Tape Footage

Raw footage (un-edited video tape) is the property of **UonDVD**, and under no circumstances will it be released to the **Client** or **Client's** representatives.

8. Production and Editing Control

UonDVD is granted full production and editing control by **Client**.

Client agrees that **UonDVD** shall not be held liable for omissions in the documentary narrative of the wedding, whether by virtue of failing to record specific events, or by virtue of editorial decision not to include recorded material in the edited wedding video.

Client agrees to provide **UonDVD** with photographs for DVD cover (Front and Back cover).

These photographs may be obtained from your event photographer. **UonDVD** will use these photographs for the DVD cover only and will indicate on the cover that photography was done by the specific photographer's company.

NOTE: If the client will not provide material for DVD cover, UonDVD will use design the DVD cover. If the client is not happy with our design, UonDVD will charge \$150/hour to redesign the DVD cover.

If something occurs at the wedding that **Client** does not want to appear in the edited videotape, **Client** must instruct **UonDVD** before editing begins.

Re-editing of the completed wedding video by **UonDVD**, whether for additions or deletions, will be billed to Client at the rate of \$150.00 per hour.

9. Copies of tape to be provided to Client.

- a. **UonDVD** will provide copies of the completed DVDs/Video tapes, with printed spine label and protective boxes as per the type of package that **Client** will be purchasing.
- b. Additional copies of the completed DVDs/Video tapes, including printed spine label and cardboard protective sleeve for each copy, will be provided to **Client** at the regular **UonDVD** duplication rate upon request.

10. Copyright Protection

The wedding video is copyright protected by **UonDVD**. Delivery of the finished video does not convey or imply transfer of copyright. Copies of the finished wedding video may only be made by **UonDVD**. Copyright © 2005, UonDVD Video Productions - All rights reserved.

11. Safety of Videographers

UonDVD reserves the right to discontinue videotaping in any situation that would put either the safety of the videographer(s) or equipment at risk.

12. Meal Arrangements

If the period for which UonDVD has been contracted extends over the luncheon or dinner hour, the **Client** can either:

Agree to provide food for video crew

Have UonDVD bring our own food

If the reception meal consists of a buffet, it is up to a **Client** to allow UonDVD crew to eat from the buffet. **Client** agrees to allow up to 20 minutes for eating time in the main dining area one videographers at one time. This arrangement will insure full-time reception video coverage.

13. Limitation of Liability

UonDVD liability is limited to a refund of money paid in the unlikely event that a problem arises specifically due to lateness, no-show, equipment or other failures, loss of materials or **UonDVD** inability to provide a videotape of the event.

14. Miscellaneous

Any failure to pay the balance of the amount owing will bear interest at the rate of 1-1/2% per month. In the event **UonDVD** is required to retain an attorney to enforce payment or any other covenant of this Agreement, client shall pay all attorneys' fees and cost incurred by **UonDVD** in connection therewith. This Agreement will be interpreted under the laws of the State of Texas and venue for any action shall be in Dallas County or any other Texas Counties.

15. Firm and Binding Agreement

A firm and binding agreement exists between **UonDVD** and the **Client** only after this agreement has been properly executed and a deposit of one third the contractual amount has been received by **UonDVD**.

This agreement supersedes and replaces any previous document, correspondence, conversation or other written and/or oral understanding.

UonDVD and **Client** mutually agree to the terms and conditions of this contract. Any additions will be subject to a separate written contract.

If any portion of this agreement should be determined to be invalid, it is agreed that the invalidity of such portion shall not affect the validity of the remaining portions of this agreement.
